## Competition Rules:

- Modified IJF rules: Shime-waza (chokes) not allowed for juniors 12 years and under. Kansetsu-waza (arm locks) not allowed on Juniors 16 years and under.
- Judoka with blue gi must also have a white gi
- Match time 3 minutes for juniors, 5 minutes for seniors, 3 minutes for masters

**Awards:** Medals for 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> place in all divisions.

**Entry Fee:** \$25.00 per contestant, \$10.00 for each additional division.

**Divisions:** Junior and master's divisions will be based upon participation. Seniors will be standard weight divisions if possible. *(Tournament director retains the right to combine divisions based on participation.)*

### WARNING WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE:

In consideration of being permitted to participate in any way, including travel to and from the MJJ State Judo Tournament, and related events and activities of the USA Judo Inc., USJA, USJF, Missouri Judo Inc., Welcome Mat Judo Club and the City of Kansas City, MO or any related facilities, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo and the importance of these rules.
2. Agree that prior to participating, I will inspect the mats, equipment, facilities, competition pools and or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, and the tournament director of such conditions(s) and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, traumatic brain injury and severe social and economic losses due to not only my own actions, inactions or negligence, but also to the action, inaction or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo I assume that risk and accept personal responsibility for the damages following such injury, permanent disability or death.
5. Release, waive and discharge and covenant not to sue the USA Judo, Inc., USJA, USJF, Missouri Judo Inc., Welcome Mat Judo Club, City of Kansas City, MO, Kansas City North Community Center together with their affiliated clubs, the respective administrators, directors, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians(s), supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees or premises used to conduct the event, all of whom are hereinafter referred to as the "releases", from any and all claims, demands, losses, or damages on account of injury, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise to the fullest extent permitted by law.
